ANNOUNCEMENT

The Public Prosecutor's Office of the Republic of Cuba convenes the 15th International Meeting on Criminal Sciences 2023 and the 3rd Event on Legality, Law and Society, to be held at the Convention Center in Havana, Cuba, from **March 15 to 17, 2023**, co-sponsored by the National Union of Jurists of Cuba and the University of Havana Law School.

The distinct academic and scientific tradition of this event makes it a conducive forum for the discussion of key issues that transcend Society and Law, with special reference to criminal sciences, in a globalized world immersed in the confrontation of the pandemic caused by COVID-19, which unquestionably impacts on all spheres of life processes, with an evident health, economic, social and legal crisis.

In this scenario, prosecutors, attorneys, lawyers, judges, police officers, penitentiary specialists, criminalists, criminologists, victimologists, forensic doctors, forensic psychiatrists, officials who work with under-age victims and minors with behavioral disorders, psychologists, sociologists, comptrollers, auditors, economists, legal advisors, professors, university students and other professionals are invited to debate from a multidisciplinary perspective that allows us to present our points of view and build alternatives and solutions to the problems of the contemporary legal environment among all of us.

- The role of the State as a guarantee of efficient public management
- State, Society and Law in the fight against corruption and other associated manifestations

- Effective judicial protection and Due Process, the main axes in the criminal debate.

- Economic and civil service crimes
- Gender, Law and Violence Prevention
- Models of sentence execution. The execution of sentences in persons deprived of liberty
- Challenges of the Substantive and Procedural Criminal Reform in Cuba
- The empowerment of women from a constitutional perspective. Role of the prosecutor in the defense of their rights
- New Family Code in Cuba as the maximum expression of the protection of people's rights. Participation of the Prosecutor

The event will comprise Lectures, Keynote Speeches and Papers previously selected by the Scientific Committee, which shall be submitted digitally by January 4, 2023. Delegates may also participate as delegates who, without presenting papers, cover the established registration fee.

Those interested should include the following information: name(s) and surname(s) of the author(s) (up to two per paper), title of the paper, institution to which it belongs and e-mail address.

Papers should not exceed 30 pages and should be presented in Times New Roman font, size 12, spacing 1.5, justified text, citations and bibliographical references according to APA style guidelines. In addition, an abstract of 250 to 500 words, including key words, should be submitted via e-mail to cienciaspenales2023@fgr.gob.cu.

For delegates, speakers and students, the registration fee includes accreditation / access to all scientific activities / certificate of participation and attending the closing ceremony. Delegates who attend remotely, will receive the certificate of participation.
